

## NOTES TO APPLICATION/RENEWAL FORM INCLUSION IN THE REGISTER OF PRACTICES UNDER HKILA

**\*Please read these notes before completing your application**

### **A. Requirements for inclusion in the register of practices**

A practice/office which is engaged in providing services for Landscape Architecture (e.g. landscape planning, design, and/or management) may apply for inclusion in the List of Registered Practices under the Hong Kong Institute of Landscape Architects (HKILA), the practice/office must have:-

(a) at least one landscape principal having professional or fellow HKILA membership; and

(b) he/she is a partner or director of the practice with full legal, managerial and financial responsibility for the landscape work of the practice.

A practice/office should notify the HKILA as soon as the conditions stated in para (a) or (b) above are not satisfied. The practice or office is automatically excluded immediately as a Registered Practice.

A multi-disciplinary practice which has a professional or fellow HKILA member as an employee without the responsibility as listed in above para. (b) is not eligible for registration as a registered practice.

### **B. Information required**

The application / renewal shall be supported with the following information:-

(a) completed Application/Renewal Form;

(b) for new application, a certified true copy of Business Registration Certificate with a landscape principal's signature and membership chop affixed.

### **C. Registration Fee**

The annual registration fee is subject to annual review.

Currently, cheque in the sum of **\$5,100** as annual registration fee shall be made payable to "The Hong Kong Institute of Landscape Architects".

### **D. Delivery**
